2 DECLARING FEBRUARY 4, 2008 "NEW MEXICO MESA DAY".

4 WHEREAS, New Mexico MESA, inc., a nonprofit
5 organization, in partnership with schools and universities,
6 promotes educational enrichment for pre-college students from
7 historically underrepresented ethnic groups; and

8 WHEREAS, currently New Mexico MESA, inc., is in one
9 hundred ten schools statewide and has grown dramatically since
10 its introduction in 1982 in seven schools; and

11 WHEREAS, New Mexico MESA, inc., provides thousands of
12 middle, junior and high school students with year-round
13 support and career guidance; and

14 WHEREAS, New Mexico MESA, inc., activities include
15 tutoring, advanced study, college and career counseling, field
16 trips and academic competitions, leadership workshops, summer
17 programs, scholarship incentives, community services and
18 teacher professional development; and

19 WHEREAS, New Mexico MESA, inc., provides support not
20 only to students but also to their teachers, families and
21 communities; and

22 WHEREAS, through New Mexico MESA, inc.'s, efforts,
23 participating students receive the educational enrichment
24 experiences and practical help they need to achieve academic
25 excellence and prepare for college majors in mathematics,

2 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF
3 REPRESENTATIVES OF THE STATE OF NEW MEXICO that it designate
4 February 4, 2008 as "New Mexico MESA Day"; and
